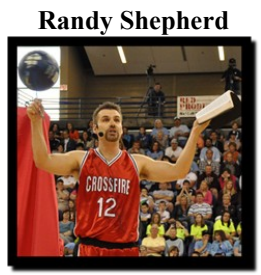
**About Crossfire Ministry**
